Thank you for your request for access to documents of the Council of the European Union.<sup>1</sup>

Please find attached, as requested, document **WK 10284/2025 ADD 1** as well as partially accessible versions of documents **WK 10247/2025 INIT** and **WK 10284/2025 INIT**.<sup>2</sup> However, I regret to inform you that full access cannot be given to these documents for the reasons set out below.

Document **WK 10247/2025 INIT** is a request for contribution of 24 July 2025 from the General Secretariat of the Council to the Working Party on International Environment Issues (Global) WPIEI (Global) which contains a call for comments on the revised draft EU+MS scenario C for Article 6 (Sustainable production) for the INC-5.2 preparation.

Document **WK 10284/2025 INIT** is a consultation of 25 July 2025 from the General Secretariat of the Council to the Working Party on International Environment Issues (Global) on the INC-5.2 preparation. It concerns an informal silence procedure on the revised draft EU+MS scenario C for Article 6 (Sustainable production).

These documents contain different scenarios on the EU negotiating position for Article 6 (Sustainable production) in view of the second part of the fifth session of the Intergovernmental Negotiating Committee to develop an international legally binding instrument on plastic pollution, including in the marine environment (INC-5.2) which took place in Geneva from 5 to 15 August 2025. No agreement could be reached at this session and the negotiations should resume in the future even if no date has yet been set.

Article 6 is one of the most sensitive issues at the core of the treaty. Any disclosure of the EU scenario concerning this article would undermine the EU position in these forthcoming negotiations. Full release of the information contained in these documents at this point would have a negative impact on the relations of the European Union with the other negotiating parties. Should its internal views and negotiation strategy be made public while negotiations are ongoing, the position of the Union in such international negotiations would be seriously weakened.

Full disclosure of the documents would therefore undermine the protection of the public interest as regards international relations. As a consequence, the General Secretariat is not able to grant a full access to the documents.<sup>3</sup>

However, as abovementioned, pursuant to Article 4(6) of the Regulation, you may have access to those parts of the documents which are not covered by this exception. Please note that documents **WK 10247/2025 INIT** and **WK 10284/2025 INIT** are redacted for personal data.<sup>4</sup>

Subject: Internal review of access to documents request - Working documents on plastics treaty

Dear Council of the European Union,

Please pass this on to the person who reviews confirmatory applications.

I am filing the following confirmatory application with regards to my access to documents request 'Working documents on plastics treaty'.

In its reply, the Council argued that disclosure of several documents on negotiations over Article 6 of the Plastics Treaty would reveal its internal views and negotiation strategy, and therefore weaken the EU's negotiating position.

I wish to contest that decision, and ask for the disclosure of all documents mentioned in the Council's reply.

In its judgement in the joined cases T-682/21 and T-683/21, the General Court found that "the existence of a mere link between the elements contained in a document which is the subject of an application for access and the objectives pursued by the European Union in the negotiation and implementation of an international agreement is not sufficient to establish that disclosure of those elements would undermine the public interest protected as regards international relations" (paragraph 112). The court held in regard to legal opinions that "the risk of divergences of legal assessment or interpretation is an integral part of any legislative procedure and such divergences are therefore liable to be explained to non-member countries or international organisations in an international body such as the meeting of the parties to the Aarhus Convention, without necessarily weakening the European Union's position resulting from the final version of the act ultimately adopted." (paragraph 114)

I believe that in the present case, the Council did not deliver a convincing explanation why the documents in questions would undermine the EU's negotiating position. The fact that member state's positions diverge is well-known, and indeed that is a healthy part of the democratic debate.
