COUNCIL DECISION

on the signing, on behalf of the Union, of an Agreement between the European Union, of the one part, and the Kingdom of Norway, of the other part, laying down the rules for participation of the Kingdom of Norway in the GOVSATCOM component of the Union Space Programme and in the Union Secure Connectivity Programme

EXPLANATORY MEMORANDUM

1. CONTEXT OF THE PROPOSAL

• Reasons for and objectives of the proposal

Norway is the closest EU Space partner participating in most of the components of the Union Space Programme¹, with some exceptions including the GOVSATCOM component.

On 20 April 2023 Norway requested to start negotiations on an agreement in view of participating in the GOVSATCOM component of the Union Space Programme and in the Union Secure Connectivity Programme. On 10 December 2024 the Council authorised the opening of the negotiations on behalf of the Union.²

As defined in the Union Security Connectivity Programme Regulation (EU) 2023/588³ (the ‘Secure Connectivity Regulation’) and in the Union Space Programme Regulation (EU) 2021/696⁴ (the ‘Space Regulation’), the participation of third countries in respectively Secure Connectivity and GOVSATCOM shall be organised via a stand-alone international agreement in accordance with Article 218 of the TFEU.

The Norwegian participation in Secure Connectivity and GOVSATCOM will be concluded in one agreement because both programmes are intertwined, GOVSATCOM being also the service centre for Secure Connectivity and because the same conditions apply to Norway’s participation in both programmes.

From a geopolitical point of view, the participation of Norway in the GOVSATCOM component of the Union Space Programme and in the Union Secure Connectivity Programme is of interest to the Union as it will contribute to strengthening Europe’s role as a global actor as it enlarges the Secure Connectivity use beyond the Union borders and will also promote international cooperation as defined in the Space Strategy for Europe⁵. An Agreement with Norway strengthens the EU strategic posture which is an objective of the European Union Space Strategy for Security and Defence⁶.

The participation of a third country like Norway is of interest to the European Union, also because by enlarging the use of Secure Connectivity, it generates income for the European Union.

- **Consistency with existing policy provisions in the policy area**

The Secure Connectivity Regulation offers the possibility to open the Secure Connectivity Programme to third countries, the first category of which are the EEA EFTA countries.

An agreement with Norway will complement the Union Secure Connectivity Programme. An agreement will also promote and strengthen Secure Connectivity outside the Union, in the strategically important high North.

- **Consistency with other Union policies**

Given Norway's beneficial geographical location near the Arctic region Secure Connectivity is important to support key economic sectors, in particular telecommunications and transport.

A Secure Connectivity agreement with Norway contributes to a number of EU priorities including the Green Deal, a Europe fit for the digital age, an economy that works for people and a stronger Europe in the World.

Given Norway's beneficial geographical location near the Arctic region, an agreement will also contribute to peace and security and the sustainable development of the Earth.

The Strategic Compass for security and defence adopted by the Council on 21 March 2022 proposes that the EU space systems offer global connectivity to security and defence actors. It also calls for the Union to work on the proposal for an EU space-based global secure communication system. An agreement with Norway will contribute to that.

2. LEGAL BASIS, SUBSIDIARITY AND PROPORTIONALITY

- **Legal basis**

Under Article 189(2) TFEU, the European Parliament and the Council, acting in accordance with the ordinary legislative procedure, should put in place the necessary measures to attain the objectives of a European space policy. One measure is to conclude international space cooperation agreements, such as the one prepared under this initiative.

Article 218(5) of the Treaty on the Functioning of the European Union (TFEU) provides that the Council, on a proposal by the negotiator, shall adopt a decision authorising the signing of the agreement and, if necessary, its provisional application before entry into force.

- **Subsidiarity (for non-exclusive competence)**

Through the Secure Connectivity Regulation and the Space Regulation, the Union is tasked to provide resilient, global, secure, protected, uninterrupted, guaranteed and flexible satellite communication solutions, built on a Union technological and industrial base, in order to increase the resilience of Member States' and Union institutions' operations.

Since the Union Secure Connectivity Programme and the Union Space Programme are Union programmes, the participation of third countries to both programmes cannot be achieved by the EU Member States themselves.

- **Proportionality and choice of the instrument**

As defined in the Secure Connectivity Regulation and in the Space Regulation, the participation of third countries in respectively Secure Connectivity and GOVSATCOM shall be organised via a stand-alone international agreement in accordance with Article 218 of the TFEU with a view to creating rights and obligations between the parties.

3. RESULTS OF EX-POST EVALUATIONS, STAKEHOLDER CONSULTATIONS AND IMPACT ASSESSMENTS

- **Collection and use of expertise**

The Commission collected the necessary information and expertise, also in its discussions with EU Member States, including on the participation rights and obligations of non-EU countries as referred to in the Secure Connectivity Regulation and the Space Regulation .

4. BUDGETARY IMPLICATIONS

Norway will contribute to the Union Secure Connectivity Programme and GOVSATCOM subcomponent based on its GDP including the adjustment for 2023-2025 for Union Secure Connectivity and for 2021-2025 for GOVSATCOM.

5. OTHER ELEMENTS

- **Implementation plans and monitoring, evaluation and reporting arrangements**

The implementation of this agreement will be monitored by the Union and Norway through a Joint Committee set up under the Agreement.

THE COUNCIL OF THE EUROPEAN UNION,

Having regard to the Treaty on the Functioning of the European Union, and in particular Article 189 in conjunction with Article 218(5) thereof,

Having regard to the proposal from the European Commission,

Whereas:

- (1) By letter of 20 April 2023, the Kingdom of Norway expressed its formal interest to start negotiations on an agreement in view of participating in the GOVSATCOM component of the Union Space Programme and in the Union Secure Connectivity Programme.
- (2) On 10 December 2024, the Council authorised the opening of negotiations on behalf of the Union of an agreement between the European Union and the Kingdom of Norway laying down the rules for participation of the Kingdom of Norway in the GOVSATCOM component of the Union Space Programme and in the Union Secure Connectivity Programme, and access to their governmental services. The negotiations were successfully concluded on 4 April 2025.
- (3) Norway has a longstanding cooperation with the Union in the area of space and is participating in most of the components of the Union Space Programme.
- (4) The Union and Norway have concluded a Security of Information Agreement.⁷
- (5) From a geopolitical point of view, the participation of Norway in the GOVSATCOM component of the Union Space Programme and in the Union Secure Connectivity Programme will contribute to strengthening Europe's role as a global actor and promote international cooperation as defined in the Space Strategy for Europe⁸. An Agreement with Norway strengthens the EU strategic posture which is an objective of the European Union Space Strategy for Security and Defence⁹.
- (6) Therefore, the Agreement should be signed on behalf of the Union, subject to its conclusion at a later date.

- (7) In accordance with the Treaties, it is for the Commission to ensure the signing of the Agreement, subject to its conclusion at a later date.

HAS ADOPTED THIS DECISION:

Article 1

The signing, on behalf of the Union, of the Agreement between the European Union, of the one part, and the Kingdom of Norway, of the other part, laying down the rules for participation of the Kingdom of Norway in the GOVSATCOM component of the Union Space Programme and in the Union Secure Connectivity Programme, and for access to their services (the 'Agreement'), is hereby authorised, subject to the conclusion of the said Agreement.

Article 2

This Decision shall enter into force on the date of its adoption.
