Subject:	Proposal for a COUNCIL DECISION on the position to be taken on behalf of the European Union in the Joint Committee established by the Agreement between the European Union and Ukraine on the carriage of freight by road as regards the recognition of smart tachographs for enforcement of the Agreement and the provision by the European Commission of smart tachograph certification services to Ukraine – Adoption

CONTEXT AND CONTENT OF THE PROPOSAL

1. On 12 November 2024, the Commission presented to the Council its proposal for a Council Decision on the position to be taken on behalf of the European Union in the Joint Committee established by the Agreement between the European Union and Ukraine on the carriage of freight by road as regards the recognition of smart tachographs for enforcement of the Agreement and the provision by the European Commission of smart tachograph certification services to Ukraine.

- 2. The Agreement between the European Union and Ukraine on the carriage of freight by road¹ (the 'Agreement') was signed by the Union on 29 June 2022 pursuant to Council Decision (EU) 2022/1158² and entered into provisional application on that date. It was concluded by the Union by Council Decision (EU) 2022/2435³ and entered into force on 5 December 2022.
- 3. The Agreement was amended by the Agreement between the European Union and Ukraine amending the Agreement between the European Union and Ukraine on the carriage of freight by road of 29 June 2022, which was signed by the Union on 20 June 2024 pursuant to Council Decision (EU) 2024/1876⁴ and entered into provisional application on that date.
- 4. The purpose of the envisaged act is to allow for the smart tachograph to be recognised as a useful tool to better enforce certain provisions of the Agreement⁵, in particular to allow competent authorities to control that road haulage operators do not engage in transport operations which are not authorised under the agreement, such as cross-trade or cabotage operations. Once this is achieved, the envisaged act also lays down certain provisions in relation to the set-up of the smart tachograph system, in particular the way for Ukraine to join the Union smart tachograph system.

EXAMINATION AT WORKING PARTY LEVEL

5. On 14 November 2024, the <u>Land Transport Working Party</u> discussed the Commission proposal. It was concluded that the Commission proposal can be adopted, subject to the revision by lawyer linguists.
