**STATEMENT BY AUSTRIA**

“Austria has repeatedly stated that it can only agree if cooperation is limited to the content of the Directive and does not include stricter national provisions of the Member States. With regard to Article 2(1) and Articles 12a to 12c as proposed in the trilogue, Austria assumes that Member States can specify the applicability of these additions and subject them to conditions, such as a requirement to obtain consent from the companies concerned.”
