*State of play*

**STATEMENT BY HUNGARY**

“Hungary considers that learning mobility – especially for those with fewer opportunities – is of key importance to the internationalisation of higher education systems in Europe and is a fundamental educational right. Therefore, Hungary agrees with the objective of this Draft Resolution to increase in higher education the share of graduates with a learning mobility experience abroad. However, the Erasmus+ programme plays a key role in achieving the objectives of the Draft Resolution. Hungary considers that the impact of the *Council Implementing Decision (EU) 2022/2506 of December 15, 2022 on measures for the protection of the Union budget against breaches of the principles of the rule of law by Hungary* makes the participation in the Erasmus+ programme impossible for 217 402 students, 19 256 teachers, as well as foreign students studying in Hungary. This sanction is an immense obstacle to mobility, therefore we plea that the first point of this document should recognise the fundamental right of all students in Hungary to be able to participate in the Erasmus programme. All other goals can only be defined after this, because this decision causes irreversible damage not only to the Hungarian people left out of the programme, but also to the entire European community. At the same time, Hungary remains committed to the internationalisation of higher education. For this purpose, the Pannonia Programme was launched to ensure that all Hungarian students have the opportunity for learning mobility.

Furthermore, Hungary, in line with its Fundamental Law and national legislation, the Treaties of the European Union and other commitments and principles stemming from international law, interprets the concept of 'gender' as reference to men and women. Furthermore, Hungary interprets the term 'diversity' in accordance with the Treaties of the European Union and the provisions of the Charter of Fundamental Rights of the European Union in the Draft Resolution.”
