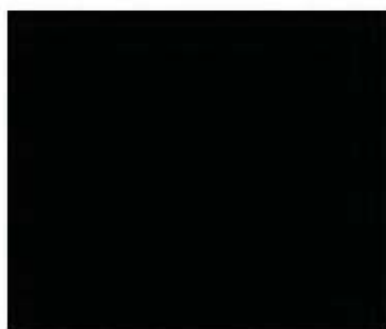
The selection panel set up pursuant to Article 14(3) of Council Regulation (EU) 2017/1939 of 12 October 2017 implementing enhanced cooperation on the establishment of the European Public Prosecutor's Office (hereinafter: 'the EPPO Regulation') has heard and ranked the candidates for the position of European Prosecutor nominated by Austria, Bulgaria, the Czech Republic, Finland and Latvia.

In accordance with Point VII.2 of the Council Implementing Decision (EU) 2018/1696 of 13 July 2018 on the operating rules of the selection panel provided for in Article 14(3) of the EPPO Regulation (hereinafter "the operating rules"), the Panel has requested Luxembourg to nominate one new candidate.

Pursuant to Points I and VII.2 of the operating rules, the Panel formulated an opinion on the qualifications of the candidates nominated by Austria, Bulgaria, the Czech Republic, Finland and Latvia to perform the duties of European Prosecutor.
