**COMMENTS ACCOMPANYING
THE DRAFT COUNCIL RECOMMENDATION ON THE DISCHARGE TO BE GIVEN TO

REGULATORS (ACER)**

The Council welcomes the Court's opinion that, in all material respects, the Agency's annual accounts present fairly its financial position as at 31 December 2024 and the results of its operations, its cash flows, and the changes in net assets for the year then ended, in accordance with the provisions of the Agency's Financial Regulation, and that the underlying transactions for 2024 are legal and regular in all material respects. Nevertheless, some observations need to be made.

The Council regrets the breach of the Financial Regulation rules for procurement procedures, whether it concerns evaluation, award or implementation of contracts, and calls on the Agency to remedy by reviewing procedures, to ensure sound financial management and minimise exposure to legal risks.

With regard to budgetary management, the Council takes note of the recurrent high rates of carry-overs, which resulted in 28 % of non-differentiated appropriations brought forward to 2025. While acknowledging the Agency's justification to cover 2024 contractual obligations, the Council recalls the importance of compliance with the principle of annuality and invites the Agency to better plan, in order to guarantee sound financial and budgetary management.

The Council welcomes the Court's opinion that the Institute's annual accounts present fairly, in all material respects, its financial position as at 31 December 2024 and the results of its operations, its cash flows, and the changes in net assets for the year then ended, in accordance with the provisions of the Institute's Financial Regulation, and that the underlying transactions for 2024 are legal and regular in all material respects. Nevertheless, some observations need to be made.

The Council notes the financial risks associated to prefinancing payments, which represent 92.9 % of total payments executed in 2024 and an amount of EUR 412 million, and, therefore, calls on the Institute to closely monitor the clearings and ensure that the changes in the grant agreements structure bring no prejudice to sound financial management.

The Council invites the Institute to enhance internal controls for compliant implementation of framework contracts, in particular related to travel services.

The Council calls on the Institute to improve its budgetary management to ensure full compliance with the Financial Regulation. In doing so, particular attention should be granted to appropriation carry-overs, drawing up and publication of accounts, as well as accountancy of revenue. The Council welcomes the Institute's commitment to revise its budget structure to avoid such occurrences in the future.

Nevertheless, some observations need to be made.

The Council takes note of the Court's observations on the legality and regularity of transactions and on the management and control systems, in particular related to procurement contract implementation and audit trail. The Council welcomes the remedial action taken so far and invites the Agency to further revise and improve procedures to ensure full compliance with the Financial Regulation.

The Council takes note of the recurrent high rates of carry-overs, which resulted in 16.3 % of the year's non-differentiated appropriations, with 44.5 % under Title III, brought forward to 2025. The Council recalls the importance of compliance with the principle of annuity and calls on the Agency to improve its budgetary management.

The Council also notes the Agency's recurrent practice of making payments outside the legal deadline and acknowledges at the same time that no late payment interest has been charged in 2024, as well as the Agency's commitment to address this concern.
