**COMMENT ACCOMPANYING
THE COUNCIL RECOMMENDATION ON THE DISCHARGE TO BE GIVEN TO
THE EUROPEAN EDUCATION AND CULTURE EXECUTIVE AGENCY (EACEA)**

The Council welcomes the Court's opinion that, in all material respects, the Executive Agency's annual accounts present fairly its financial position as at 31 December 2024 and the results of its operations, its cash flows, and the changes in net assets for the year then ended, in accordance with the provisions of the Executive Agency's Financial Regulation, and that the underlying transactions for 2024 are legal and regular in all material respects. Nevertheless, one observation needs to be made.

The Council takes note of the Court's observations on the transactions performed by a staff member that was not formally appointed or delegated as accounting officer, as well as on late payment execution. The Council acknowledges the action already taken and calls upon the Executive Agency to strengthen its internal control and improve its budgetary management.
