THE COUNCIL OF THE EUROPEAN UNION,

Having regard to the Treaty on the Functioning of the European Union, and in particular Article 189, in conjunction with Article 218(6), second subparagraph, point (a), thereof,

Having regard to the proposal from the European Commission,

Having regard to the consent of the European Parliament<sup>1</sup>,

Whereas:

- (1) In accordance with Council Decision (EU) .../...<sup>2+</sup>, the Agreement between the European Union and the Kingdom of Norway laying down the rules for participation of the Kingdom of Norway in the GOVSATCOM component of the Union Space Programme and in the Union Secure Connectivity Programme, and for access to GOVSATCOM services and to the governmental services of the Union Secure Connectivity Programme (the ‘Agreement’) was signed on ...<sup>++</sup>, subject to its conclusion at a later date.
- (2) From a geopolitical point of view, the participation of Norway in the GOVSATCOM component of the Union Space Programme and in the Union Secure Connectivity Programme, and Norway’s access to GOVSATCOM services and to the governmental services of the Union Secure Connectivity Programme, will contribute to strengthening Europe’s role as a global actor and promote international cooperation as defined in the Space Strategy for Europe. An Agreement with Norway will strengthen the Union’s strategic posture, which is an objective of the European Union Space Strategy for Security and Defence.
