COUNCIL DECISION

appointing two alternates to the Administrative Board of the European Union Agency for the Cooperation of Energy Regulators

THE COUNCIL OF THE EUROPEAN UNION,

Having regard to the Treaty on the Functioning of the European Union,

Having regard to Regulation (EU) 2019/942 of the European Parliament and of the Council of 5 June 2019 establishing a European Union Agency for the Cooperation of Energy Regulators¹, and in particular Article 18 thereof,

Whereas:

- (1) Regulation (EU) 2019/942 provides that the Council is to appoint five members and their alternates to the Administrative Board of the European Union Agency for the Cooperation of Energy Regulators ('the Administrative Board').
- (2) Regulation (EU) 2019/942 provides that a member of the Administrative Board is not to be a member of the Board of Regulators of the European Union Agency for the Cooperation of Energy Regulators and that the members of the Administrative Board are to act independently and objectively in the interest of the Union as a whole.
- On 8 December 2023, the Council adopted a Decision² appointing three members and three alternates to the Administrative Board for a period of four years from 28 January 2024.

 On 12 October 2024, one of those alternates, Ms Karin LUNNING, resigned as alternate of the Administrative Board.
- (4) On 24 May 2024, the Council adopted a Decision³ appointing two alternates to the Administrative Board for a period ending on 28 January 2026. On 27 September 2024, one of those alternates, Mr Wouter RAAB, resigned as alternate of the Administrative Board.
