- France requested an item under “any other business”, on the “transfer of articles from NRPP to the various CAP sectorial regulations”; and
- Portugal requested a public item under “any other business”, on the “establishment of an EU reinsurance mechanism for natural disasters in agriculture”.
- The SCA agreed that the items requested by Latvia, Romania and Portugal would be taken in public session in accordance with Article 8(2) of the rules of procedure of the Council.
