#### 'I/A' ITEM NOTE

Subject: Council Decision appointing three members and two alternate members, proposed by the Italian Republic, of the Committee of the Regions  
- Adoption

---

1. By letters of 10 November 2025<sup>1</sup>, 17 December 2025<sup>2</sup>, 6 February 2026<sup>3</sup>, and 13 February 2026<sup>4</sup>, the Secretary-General of the Committee of the Regions notified the Council of the resignation of Mr Francesco ACQUAROLI, member of the Committee of the Regions, and of Ms Roberta ANGELILLI, alternate member of the Committee of the Regions, as well as of the end of the national mandate on the basis of which Mr Luciano Emilio CAVERI and Mr Luca ZAIA, members of the Committee of the Regions, and Mr Michele EMILIANO, alternate member of the Committee of the Regions, were proposed for appointment and appointed.
2. Under Article 305 TFEU, the Council, acting by a qualified majority on proposals by the respective Member States, appoints members and alternate members of the Committee of the Regions.

3. In accordance with that provision and for the purpose of the replacement of Mr Francesco ACQUAROLI, Mr Luciano Emilio CAVERI and Mr Luca ZAIA, the Italian Government has proposed<sup>5</sup> the following representatives of regional bodies who hold a regional authority electoral mandate: Ms Roberta ANGELILLI, *Assessore della Regione Lazio* (Regional Minister of the Lazio Region), Mr Aurelio MARGUERETTAZ, *Consigliere regionale, Consiglio regionale della Valle d'Aosta* (Regional Councilor, Regional Council of Valle d'Aosta), and Mr Alberto STEFANI, *Presidente della Regione Veneto* (President of the Veneto Region), as members of the Committee of the Regions for the remainder of the current term of office, which runs until 25 January 2030.
4. In addition, and for the purpose of the replacement of Ms Roberta ANGELILLI and Mr Michele EMILIANO, the Italian Government has proposed<sup>5</sup> the following representatives of regional bodies who hold a regional authority electoral mandate: Mr Francesco ACQUAROLI, *Presidente della Regione Marche* (President of the Marche Region), and Mr Antonio DECARO, *Presidente della Regione Puglia* (President of the Puglia Region), as alternate members of the Committee of the Regions for the remainder of the current term of office, which runs until 25 January 2030.
5. The Permanent Representatives Committee is therefore invited to confirm its agreement on the text of the Decision, as set out in document 7383/26, and to suggest that the Council adopt that Decision as an 'A' item at a forthcoming meeting.
