The Mission of the Principality of Liechtenstein to the European Union presents its compliments to the General Secretariat of the Council of the European Union and has the honour to refer to the Council's notification of 17 May 2024 and its own notification of 14 June 2024, the latter informing the General Secretariat of the Council of the European Union of the acceptance of the below mentioned legal acts, subject to the fulfilment of constitutional requirements in Liechtenstein in accordance with the second and third sentence of Article 5(2)(a) in combination with Article 5(2)(b) of the Schengen Protocol.

In accordance with Article 5(2)(b) of the Schengen Protocol, the Mission of the Principality of Liechtenstein to the European Union has the honour to notify the General Secretariat of the Council of the European Union that the constitutional requirements regarding the following acts have been fulfilled, thereby making the acts binding on Liechtenstein:

Regulation of the European Parliament and of the Council establishing a return border procedure, and amending Regulation (EU) 2021/1148

Council Document: PE-CONS 17/24

Date of adoption: 14 May 2024

Regulation of the European Parliament and of the Council introducing the screening of third-country nationals at the external borders and amending Regulation (EC) No 767/2008, (EU) 2017/2226, (EU) 2018/1240 and (EU) 2019/817

Council Document: PE-CONS 20/24

Date of adoption: 14 May 2024

The exchange of notes referred to above shall therefore enter into force on the date of this notification.
