### Statement by Germany

„Die Bundesregierung begrüßt grundsätzlich, dass mit der delegierten Verordnung ein harmonisiertes Verfahren zur Meldung von Produktrisiken geschaffen und damit der Schutz der Verbraucher im europäischen Binnenmarkt sichergestellt wird.

Dennoch ist Deutschland der Auffassung, dass die Mitgliedstaaten nicht ausreichend in die Erarbeitung der delegierten Verordnung einbezogen wurden. Weder hatten die Mitgliedstaaten die Möglichkeit, zum endgültigen Text der Verordnung Stellung zu nehmen, noch gab es eine Expertengruppe zu allen Aspekten des Artikels 26 Abs. 10 der allgemeinen EU-Produktsicherheitsverordnung. Die von den Mitgliedstaaten vorgebrachten Argumente wurden zudem nicht berücksichtigt.

Darüber hinaus hat Deutschland auch in inhaltlicher Hinsicht erhebliche Bedenken gegen den delegierten Rechtsakt:

Die Zuständigkeit für das Ergreifen von Abhilfemaßnahmen und die Entscheidung über die Safety-Gate Meldung liegt ausschließlich bei den zuständigen Behörden der Mitgliedstaaten. Deutschland lehnt daher die Regelungen in Anhang I ab, die diesem Grundsatz widersprechen.

Innerhalb des Anhangs II lehnt Deutschland diejenigen Regelungen ab, die den Beurteilungsspielraum der Marktüberwachungsbehörden auf „Null“ reduzieren und keinen Raum für eine individuelle Risikobewertung lassen. Insbesondere lehnt Deutschland die pauschale Annahme eines ernstesten Risikos gemäß Anhang II Ziffer 4.1 ab. Die Anforderungen gehen auch über die Ermächtigung des Art. 26 Abs. 10 der allgemeinen EU-Produktsicherheitsverordnung hinaus, da die Ermächtigung nicht vorsieht, dass die Kommission eine solche Risikobewertung eigenständig durchführt oder vorwegnimmt.

Insbesondere die Buchstaben a (für Schäden mit Schweregrad 3 oder 4), b (für freiwillige Maßnahmen der Wirtschaftsteilnehmer), d (bei Überschreitung von Grenzwerten) und e (gut dokumentierter Nachweis, dass bestimmte Eigenschaften eines Produkts zu einer ernstesten Gefahr führen) sollten nach Auffassung Deutschlands gestrichen werden.

Darüber hinaus muss die Anwendbarkeit spezieller sektorspezifischer Risikobewertungsverfahren (z.B. für chemische Risiken oder bestimmte Produkte wie Bauprodukte) in Abweichung von den Bestimmungen des Anhangs II weiterhin möglich sein.

Aus diesen Gründen lehnt Deutschland die delegierte Verordnung in der vorliegenden Form ab und bittet die Kommission, sie zu überarbeiten und dabei die Positionen der Mitgliedstaaten zu berücksichtigen.“

### Courtesy translation

The German Federal Government welcomes in principle the fact that the Delegated Regulation creates a harmonised procedure for reporting risks posed by products, thus ensuring the protection of consumers within the European internal market.

Nevertheless, Germany is of the opinion, that the member states have not been sufficiently involved in the preparation of the delegated regulation. The member states had neither the opportunity to comment on the final text of the regulation nor was there an expert group on all aspects of Article 26(10) of the General Product Safety Regulation. Arguments put forward by the Member States were not taken into account.

Furthermore, Germany has significant concerns about the delegated act also in substantive terms:

The competence to take corrective measures and to decide on the safety gate notification lies exclusively with the competent authorities of the Member States. Therefore, Germany rejects the regulations in Annex I that contradict this principle.

Within Annex II, Germany rejects the regulations in Annex II that reduce the assessment scope of the market surveillance authorities to “zero” and leave no scope for an individual risk assessment. Especially, Germany rejects the general assumption of a serious risk in accordance with Annex II point 4.1. The requirements also go beyond the authorisation of Art. 26 (10) GPSR, as the authorisation does not provide for the Commission to carry out or anticipate such a risk assessment independently.

In particular, letter a (for damage with severity level 3 or 4), letter b (for voluntary measures by economic operators), letter d (if limit values are exceeded) and letter e (well-documented evidence that certain characteristics of a product lead to a serious risk) should be deleted in Germany's opinion.

In addition, the applicability of special sector-specific risk assessment procedures (e.g. for chemical risks or certain products such as construction products) must continue to be possible by way of derogation from the provisions in Annex II.

For these reasons, Germany opposes the Delegated Regulation in this form and asks the Commission to revise it in this sense and to take the positions of the Member States into account accordingly.”
