Subject: Access to documents under Regulation (EC) No 1049/2001 - Documents relating to the ‘Epstein files’



Having regard to

- Regulation (EC) No 1049/2001 of the European Parliament and of the Council of 30 May 2001 regarding public access to European Parliament, Council and Commission documents, and
- the Charter of Fundamental Rights of the European Union, in particular Articles 41 (good administration) and 42 (access to documents);

Requests access

to a digital certified copy of the following documentation:

- all documents, communications and text messages (SMS, iMessage, WhatsApp, Signal or similar) exchanged between the Council, or its officials, and other EU agencies or institutions, governments and/or institutions of EU Member States and non-EU countries, citizens and natural or legal persons, concerning the disclosure by the government of the United States of America of the ‘Epstein files’, i.e. the documents gathered during the judicial proceedings against the late Jeffrey Epstein;
- all documents, communications and text messages (SMS, iMessage, WhatsApp, Signal or similar) exchanged between the Council, or its officials, and other EU agencies or institutions, governments and/or institutions of EU Member States and non-EU countries, citizens and natural or legal persons, that shed light on any relationships of a financial and/or personal nature between the late Jeffrey Epstein and senior officials of the EU institutions, the EU Member States, and/or third countries;

- all documents, communications and text messages (SMS, iMessage, WhatsApp, Signal or similar) exchanged between the Council, or its officials, and other EU agencies or institutions, governments and/or institutions of EU Member States and non-EU countries, citizens and natural or legal persons, regarding internal and/or external investigations launched by the Council into any relationships of a financial and/or personal nature between the late Jeffrey Epstein and senior officials of the EU institutions, the EU Member States, and/or third countries;
- It should be noted that this request concerns both documents drawn up by the Council and documents it holds of the abovementioned nature received from third parties.

Reasons for the request

This request for access to documents is based on an overriding public interest, within the meaning of Regulation (EC) No 1049/2001, as it concerns documents and communications that have a significant institutional and reputational impact on the European Union. This request concerns exchanges between the Council, or its officials, and other EU institutions, Member States, third countries and private individuals concerning the disclosure by the government of the United States of America of the ‘Epstein files’ and the possible presence within such documents of senior EU officials or officials from third countries.

Access to the documents requested is necessary to enable citizens to understand the nature and content of the Council’s communications with governments, institutions, and actors from outside the Union, any political, legal or diplomatic assessments made or shared, and the degree to which the EU’s action is consistent with the principles of transparency, institutional responsibility and protection of the integrity of its own institutions.

The matters covered by this request fall fully within the scope of the European Union’s action, both internal and external, as they relate to the management of relations with third countries, the protection of the reputation of EU institutions, and the prevention of potential risks to the EU’s credibility internationally.

Transparency as regards these documents is therefore essential to enable citizens and oversight bodies to assess the compliance of the Council’s work with the principles enshrined in EU law. In this context, access to the documents requested will serve to verify whether the Council has adopted institutional monitoring, evaluation or communication measures in relation to the disclosure of the ‘Epstein files’, and to provide an understanding of the possible implications of those events for the reputation and integrity of the EU institutions.

Inapplicability of the exceptions provided for in Article 4(1)(a) and (b) of Regulation (EC) No 1049/2001

Subparagraph (a)

The disclosure of the documents requested does not undermine the protection of public security, defence and military matters, international relations or the financial policies of the Union.

The request concerns documents and communications of an institutional and diplomatic nature or information the dissemination of which could specifically harm the interests protected by Article 4(1)(a) of Regulation (EC) No 1049/2001.

Subparagraph b)

The events that are the subject of this request, the disclosure of the ‘Epstein files’ and the possible presence within them of EU or third-country officials, are matters in the public domain, widely reported by international institutional and media sources.

A response is expected within the deadlines set out in Article 7(1) of Regulation (EC) No 1049/2001.

The report is an internal document.

Full disclosure of the information contained in the document would undermine relations between the European Union and third countries.

Full disclosure of the document would therefore undermine the protection of the public interest as regards international relations. Consequently, the General Secretariat must refuse full access to the document in question.¹

This document does not exist in the language version requested.

Pursuant to Article 7(2) of Regulation (EC) No 1049/2001, you may ask the Council to review this decision within 15 working days of receiving this reply. Should you consider such a review necessary, please state the reasons for your request.
