Thank you for your request for access to documents of the Council of the European Union.¹

I regret to inform you that access to document **ST 14806/24** cannot be given for the reasons set out below.

The requested document, drawn up by European External Action Service (EEAS) for the Political and Security Committee, contains the Strategic Review of <u>EUCAP Sahel Mali</u> and the <u>Regional Advisory and Coordination Cell</u>. It contains, among other sensitive information, internal detailed analyses of the international relations and of the political and security situation of certain countries with respect to the Sahel region.

The General Secretariat of the Council has examined your request on the basis of the applicable rules: Regulation (EC) No 1049/2001 of the European Parliament and of the Council regarding public access to European Parliament, Council and Commission documents (OJ L 145, 31.5.2001, p. 43) and the specific provisions concerning public access to Council documents set out in Annex II to the Council's Rules of Procedure (Council Decision No 2009/937/EU, OJ L 325, 11.12.2009, p. 35).

Following our consultations with the EEAS, the General Secretariat is of the opinion that the release of the security-related information contained in this strategic document would cause prejudice to the proper functioning of the EU Missions concerned and the safety of personnel involved therein, potentially increasing the security challenges and threats (a non-hypothetical, but very concrete risk). Moreover, the disclosure of the abovementioned internal analyses of the political and security situation in the region would negatively affect EU's international relations with the third countries concerned.

Consequently, access to the requested document cannot be granted.²

We have also looked into the possibility of releasing parts of document **ST 14806/24**.³ However, as the information contained therein forms an inseparable whole, the General Secretariat is unable to give partial access.

Pursuant to Article 7(2) of Regulation (EC) No 1049/2001, you may ask the Council to review this decision within 15 working days of receiving this reply. Should you see the need for such a review, you are invited to indicate the reasons thereof.
