THE COUNCIL OF THE EUROPEAN UNION,

Having regard to the Treaty on the Functioning of the European Union, and in particular Article 305 thereof,

Having regard to Council Decision (EU) 2019/852 of 21 May 2019 determining the composition of the Committee of the Regions<sup>1</sup>,

Having regard to the proposal of the Danish Government,

Whereas:

- (1) Pursuant to Article 300(3) of the Treaty, the Committee of the Regions is to consist of representatives of regional and local bodies who either hold a regional or local authority electoral mandate or are politically accountable to an elected assembly.
- (2) On 10 December 2024, the Council adopted Decision (EU) 2025/71<sup>2</sup>, appointing the members and alternate members of the Committee of the Regions for the period from 26 January 2025 to 25 January 2030.
- (3) Seven members' seats on the Committee of the Regions have become vacant following the resignations of Mr Bent GRAVERSEN, Mr Kasper Egede GLYNGØ, Ms Kirsten Maria Meyer JENSEN, Mr Karsten Søndergaard NIELSEN, and Ms Hanne ROED, and the end of the national mandate on the basis of which Mr Erik FLYVHOLM and Mr Karsten Uno PETERSEN were proposed for appointment.
- (4) Six alternate members' seats on the Committee of the Regions have become vacant following the resignation of Ms Anne MADSEN and Mr Thomas ROHDEN, and the end of the national mandate on the basis of which Mr Jens Christian GJESING, Mr Henrik Gottlieb HANSEN, Mr Tage LEEGAARD, and Mr Mads SØRENSEN were proposed for appointment.
- (5) Two alternate members' seats will become vacant following the appointment of Ms Line Krogh LAY and Mr Piet Papageorge TIMMERMANN as members of the Committee of the Regions.

HAS ADOPTED THIS DECISION:

## Article 1
