On page 16, paragraph 39 should read as follows:

39. Member States will in their programming ensure appropriate investments for cohesion policy measures in all categories of regions, taking into account current investment levels. If the allocation to transition and more developed regions is lower than [2575] % of the current investment level, Member States will provide a justification based on objective criteria.

On page 16, paragraph 40 should read as follows:

40. The Plans will be assessed by the Commission within four months of the submission and approved by the Council. Amendments to the Plans will be assessed by the Commission within three months of the submission of the amended Plan and approved by the Council. ~~The Commission may, in duly justified cases, propose to the Member State to amend existing measures or to introduce new measures.~~

On page 26, paragraph 68 should read as follows:

68. The share of the cross-border cooperation corresponds to the sum of the weights of criteria ~~(a)~~**i** and ~~(b)~~**ii**. The share of the transnational cooperation corresponds to the weight of criterion ~~(c)~~**iii**. The share of the outermost regions' cooperation corresponds to the weight of criterion ~~(d)~~**iv**.

On page 35, paragraph 94 should read as follows:

94. The indicative financial envelope for Horizon Europe for the period 2028-2034 will be EUR [148 579] million, of which
- i) EUR [37 42~~40~~**40**] million for Excellent Science;
 - ii) EUR [64 145~~415~~**419**] million for Competitiveness and Society;
 - iii) EUR [32 929] million for Innovation;
 - iv) EUR [13 807] million for the European Research Area, of which [4 573] million for widening participation.

On page 35, paragraph 96 should read as follows:

96. The indicative financial envelope for the implementation of the Connecting Europe Facility for the period 2028-2034 will be EUR [69 309] million, of which:
- i) EUR [43 889] million for transport and military mobility[, of which EUR [15 110] **million** for military mobility].
 - ii) EUR [25 420] million for energy.

On page 41, paragraph 110 should read as follows:

110. The Instrument should enable the provision of support up to a maximum amount of EUR [95 000] million (in current prices) in the form of budgetary guarantees, Euratom loans, loans in the form of macro- financial assistance, and policy-based loans notably to partner countries implementing performance-based plans. [Policy-based loans will be made available through implementing acts]. An indicative amount of EUR [19 000] ~~billion~~ **million** (in current prices) will be allocated to the EIB.

On page 49, in the table ‘Annex. Multiannual financial framework 2028-2034 (in commitments)’, in the line ‘Common Agricultural Policy (CAP) income support’, in the column ‘COM proposal Total 2028-2034 (2025 prices)’, the number should read as follows: ~~259,231~~ **261,009**.

On page 49, in the table ‘Annex. Multiannual financial framework 2028-2034 (in commitments)’, in the first column, the title of the line ‘*Economic, territorial and social cohesion including fisheries and rural communities*’ should read as follows: ‘*Economic, territorial and social cohesion including fisheries and rural communities **and tourism***’.
