On page 8, in Table 4.2.1, Category 2, point (c), should be corrected as follows:

‘(c) there is evidence of a plausible biological link between the endocrine activity and the adverse effect.’,

‘(c) there is evidence of a biologically plausible link between the endocrine activity and the adverse effect.’

On page 17, Section 4.3.3.2 should be corrected as follows:
