THE COUNCIL OF THE EUROPEAN UNION,

Having regard to the Treaty on the Functioning of the European Union, and in particular Articles 186 and 212 in conjunction with Article 218(6), second subparagraph, point (a), thereof,

Having regard to the proposal from the European Commission,

Having regard to the consent of the European Parliament¹,

Whereas:

- (1) In accordance with Council Decision (EU) .../...²⁺, the Agreement between the European Union, of the one part, and the Government of Japan, of the other part, on the participation of the Government of Japan in Union programmes (the ‘Agreement’) was signed on ...⁺⁺, subject to its conclusion at a later date.
- (2) Horizon Europe – the Framework Programme for Research and Innovation (2021-2027) was established by Regulation (EU) 2021/695 of the European Parliament and of the Council³. In line with the Council’s mandate, the Protocol on the terms and conditions for the association of the Government of Japan to Horizon Europe – the Framework Programme for Research and Innovation (2021-2027) was negotiated in parallel to the Agreement and, pursuant to Article 17(9) of the Agreement, forms an integral part thereof.
- (3) The Agreement should be approved,
