1. On 24 August 2026, the Commission submitted to the Council proposal for transfer of appropriations No DEC 13/2026 related to the mobilisation of the European Globalisation Adjustment Fund (EGF/2026/002 ES/Galicia automotive ancillary)<sup>1</sup>, in accordance with Article 31(1) of the Financial Regulation<sup>2</sup>.
2. As recorded in document 12512/26, the purpose of this proposal is to transfer an amount of EUR 2.73 million in commitment appropriations from Article 30 04 02 (*Reserve for the European Globalisation Adjustment Fund for Displaced Workers (EGF)*) to Article 16 02 02 (*European Globalisation Adjustment Fund for Displaced Workers (EGF)*).
