THE COUNCIL OF THE EUROPEAN UNION,

Having regard to the Treaty on the Functioning of the European Union,

Having regard to Regulation (EU) No 492/2011 of the European Parliament and of the Council of 5 April 2011 on freedom of movement for workers within the Union¹, and in particular Articles 23 and 24 thereof,

Having regard to the lists of candidates submitted to the Council by the Governments of the Member States,

Whereas:

- (1) By means of Decisions of 23 September 2024² and 19 June 2025³, the Council appointed members and alternate members of the Advisory Committee on freedom of movement for workers (the ‘Committee’) for the period from 25 September 2024 to 24 September 2026.
- (2) Members and alternate members of the Committee remain in office until they are replaced or reappointed.
- (3) Members and alternate members of the Committee should be appointed for a period of two years,
