THE COUNCIL OF THE EUROPEAN UNION,

Having regard to the Treaty on the Functioning of the European Union, and in particular Article 95,
in conjunction with Article 218(9), thereof,

Having regard to Council Regulation (EC) No 2894/94 of 28 November 1994 concerning
arrangements for implementing the Agreement on the European Economic Area¹, and in particular
Article 1(3) thereof,

Having regard to the proposal from the European Commission,

Whereas:

- (1) The Agreement on the European Economic Area² (the ‘EEA Agreement’) entered into force on 1 January 1994.
- (2) Pursuant to Article 98 of the EEA Agreement, the EEA Joint Committee is able to amend, inter alia, Annex IV (Energy) to the EEA Agreement.
- (3) It is appropriate to incorporate Commission Regulation (EU) 2015/703³ into the EEA Agreement.
- (4) Annex IV (Energy) to the EEA Agreement should therefore be amended accordingly.
- (5) It is therefore appropriate to establish the position to be adopted within the EEA Joint Committee concerning the amendment of Annex IV (Energy) to the EEA Agreement,
