Dear Secretary-General,

I would kindly ask you to initiate the appointment procedure laid down in Article 305 TFEU for the following new nominations to the Committee of the Regions (CoR).

The Free State of Saxony has nominated Mr Martin Dulig, former Staatsminister (Minister of State), Mitglied des Sächsischen Landtages (Member of the Saxon State Parliament), as a new member for the eighth term of office. The new nomination has become necessary as Ms Katja Meier, former Staatsministerin (Minister of State), Mitglied des Sächsischen Landtages (Member of the Saxon State Parliament), is to resign from her current mandate at the CoR.

The Free State of Saxony has also nominated Dr Peter Jahr, Mitglied des Kreistages des Landkreises Mittelsachsen (member of the district council of the rural district of Central Saxony), Free State of Saxony, and Mr Torsten Ruban-Zeh, Oberbürgermeister der Großen Kreisstadt Hoyerswerda (Mayor of the major district town of Hoyerswerda), as new alternate members for the eighth term of office. The new nominations are necessary since the Free State of Saxony has not yet nominated any alternate members for the eighth term of office.

The Federal Government hereby proposes that Mr Martin Dulig be appointed as a member and Dr Peter Jahr and Mr Torsten Ruban-Zeh be appointed as alternate members of the CoR for the eighth term of office.
