History 1933: Roots in CISH

- VIIth CISH Conference (Comité International des Sciences Historiques)
- Émile Lousse (1905-1986)
- François Olivier-Martin (1879 - 1952)
- Comparative project:

Analysis of the beginnings of state assemblies

- Resolution: problem to be researched with comparative methods
- Commission to organize permanent international cooperation

1936: Foundation

- Comm. Internationale pour l' Histoire des Assemblées d' États
- Comparative approach Olivier-Martin, co-founder of Société

1949/50: Re-Establishment

- UK section Helen Maud Cam (1885-1868)
- "It might be well to group parliaments with assemblies of estates..."
- Early Mod. Assemblies & Modern Parliaments
- Continental historians: topics wide apart
- English historians: interests coinciding
- "...alternative title readily intelligible in English speaking countries is desirable"→ ICHRPI

1995: Statutes 2021: Affiliation to the **American Historical Association**

- 75 annual conferences 1937-2023:


