I. Purpose

This brochure provides information about the work of the National Council committees. The subjects and topics that may be dealt with by each committee are listed below.

This brochure was published at the beginning of the XXVIIIth legislative term (24 October 2024). The items of business deliberated by the individual committees are presented on the basis of the last legislative term. The brochure in particular provides an overview of the reports submitted to Parliament by the Federal Government and its members. Examples of frequent legislative initiatives in the form of government bills that were assigned to the respective committees are also listed.

The list of items of business mentioned in this brochure is not exhaustive, nor is the list of committees conclusive. The National Council may elect new committees at any time. In addition, the National Council may, by passing legislative amendments or adopting resolutions, change the reporting obligations during the course of the legislative term.

II. What are committees and why are they established?

Committees are parliamentary bodies responsible for preliminary deliberation of items of business to be subsequently considered by the plenary. The composition of the committees reflects the majorities in the National Council. In the committees, National Council Members with expertise in the relevant areas discuss the items of business. This division of labour enables Members to specialise in the matters dealt with by the committees to which they belong. With their expertise, they help shape opinion in their respective parliamentary groups in the relevant areas.

At the beginning of the legislative term, the committees are elected by the plenary assembly. Some committees are established because the law so requires, while others are set up on the basis of agreements between the parliamentary groups (§ 32 (1) of the Federal Act of 4 July 1975 on the Rules of Procedure of the National Council – Rules of Procedure Act 1975, usually referred to as “GOG” in Austrian parliamentary language, which is short for “Geschäftsordnungsgesetz”). A separate committee may be elected for each major subject area (optional committees, so-called “Fachausschüsse”, i.e. “specialised committees”). In addition, the National Council may set up special committees (“besondere Ausschüsse”) at



any time for preliminary deliberations on important individual items of business (§ 87 (1) of the Rules of Procedure Act).

For the preliminary treatment of extensive and difficult matters, a committee may also decide to set up a sub-committee, the deliberations of which shall as a rule be confidential (§ 35 of the Rules of Procedure Act).

III. Matters dealt with by the committees of the XXVIIth legislative term

1. Mandatory vs. optional committees

The following overview shows for each committee whether it is classified as “mandatory” or “optional”. Mandatory committees are established because the law so requires, e.g. the Federal Constitutional Law (“Bundes-Verfassungsgesetz”, “B-VG” for short) or the Rules of Procedure of the National Council. Optional committees are specialised committees (“Fachausschüsse”) which the National Council may choose to establish. The list of committees actually set up in a given legislative term reflects, to some degree, the departmental designations of the individual federal ministries and thus the comprehensive subject areas within their sphere of responsibility.

2. Standing vs. non-standing committees

It will also be specified whether the committee is a “standing” or “non-standing” committee. Standing committees may be convened at any time, i.e. even while the National Council is not in session, whenever the need arises. Non-standing committees hold their meetings during the time of the National Council’s ordinary session (see Art. 28 (1) of the Federal Constitutional Law).

3. Composition of the committees

For each committee established in the XXVIIIth legislative term, the brochure specifies the number of members and substitute members as well as the distribution of committee seats between the parliamentary groups. The parliamentary groups appoint the committee members and substitute members and communicate their names in writing to the President of the National Council. The overview of each committee also shows to which parliamentary group the committee chairperson belongs.



The complete list of committee officers (chairperson, deputy chairpersons and secretaries) is shown on the overview page of the respective committee on the Parliament's website (under "Recherchieren" > "Ausschüsse"), and a list of the committee members and substitute members is also available there.

4. Frequent subjects of the committees' deliberations

Below is a brief description of the key matters dealt with in the respective committees, with a particular focus on special functions in the case of mandatory committees.

5. Reports and frequent legislative initiatives

The individual committees dealt with the reports of the Federal Government and its members as well as the legislative initiatives submitted in the form of government bills as listed below.¹

The majority of the reports of the Federal Government and its members in the XXVIIth legislative term were submitted in compliance with statutory obligations. However, some recurring reports were also submitted in response to (legally non-binding) resolutions. Some reports were submitted to the National Council by the Federal Government and its members voluntarily or as a matter of custom. Reports that were requested and submitted only once, for example in response to a resolution, are not included in this list. Statutory reporting obligations that expired during the XXVIIth legislative term are also not listed.

To give a comprehensive insight into the activities of the respective committee, the most frequent legislative initiatives that were submitted in the form of government bills in the XXVIIth legislative term are also listed.

1.2 Matters dealt with by the committee

The Committee on Labour and Social Affairs deals with all legislative proposals and motions relating to labour and social law. In addition to employment, this also includes pension, health and accident insurance and unemployment insurance. The Committee on Labour and Social Affairs also deals with regulations concerning, and support for, people with disabilities and people in need of care.

2.2 Matters dealt with by the committee

The Foreign Policy Committee deals with state treaties, legislative proposals and motions relating to Austrian foreign policy. This includes relations with neighbouring countries as well as European and international treaties, e.g. UN conventions. Development policy and development cooperation are also within the remit of the Foreign Policy Committee.

The Foreign Policy Committee may set up sub-committees in which Members discuss specific issues such as the development of autonomy in South Tyrol.

3.2 Matters dealt with by the committee

The Committee on Construction and Housing deals with legislative proposals and motions relating to construction matters and housing. This includes regulations on the further development of tenancy law and on real estate agent fees. With regard to climate protection in the building sector, this committee also deals with general conditions for reducing energy consumption in multi-family houses and promoting zero-emission individual transportation.

4.2 Matters dealt with by the committee

An Education Committee designated as “Bildungsausschuss” was established for the first time in the XXVIIIth legislative term. In the previous (XXVIIth) legislative term, similar matters were dealt with by a committee designated as “Unterrichtsausschuss” (which would literally translate as “teaching committee” or “school instruction committee”). Further information, reporting obligations and frequent legislative initiatives listed below therefore relate to the former “Unterrichtsausschuss”.

The “Unterrichtsausschuss” dealt with all legislative proposals and motions relating to schools and teaching. This included school organisation and school administration, the service regulations for teachers and their training at teacher training colleges. Since the Ministry of Education is traditionally also in charge of matters relating to religious communities (the “Kultus”), the “Unterrichtsausschuss” also dealt with certain legal matters pertaining to them, such as funding and support. The “Unterrichtsausschuss” regularly set up sub-committees in which Members and experts engaged in detailed discussions on the current state of the Austrian school system as well as initiatives for its reform.

5. Budget Committee

Mandatory committee established under Art. 51d of the Federal Constitutional Law and § 32a of the Rules of Procedure Act; standing committee

5.2 Matters dealt with by, and special functions of, the committee

The Budget Committee conducts preliminary deliberations on, among other matters, the Federal Medium-Term Expenditure Framework Act and the Federal Finance Act (see § 32a (1) of the Rules of Procedure Act). As part of these budget deliberations, a hearing of experts is held every year. Budget accompanying laws, which are needed for the implementation of federal finance laws, are also deliberated in the Budget Committee. The budget accompanying laws also amend laws whose content actually falls within the remit of other committees, such as the General Social Insurance Act.

During the preliminary deliberations on the draft Federal Finance Act in the Budget Committee, Members may submit up to five short written questions germane to the item of business under discussion to the members of the Federal Government whose budget chapter is being dealt with (so-called “budget questions”, see § 32a (5) of the Rules of Procedure Act).

In addition, the Budget Committee is responsible for preliminary deliberations on the federal financial accounts prepared by the Court of Audit (§ 32a (1) of the Rules of Procedure Act). The federal financial accounts reflect the actual federal revenues and expenditures. This allows for a retrospective review to determine whether the respective Federal Medium-Term Expenditure Framework Act and the respective Federal Finance Act have been complied with. Final disposition in committee is not possible in the case of the federal financial accounts (although they are published as a series-III annex).⁷ Their approval takes the form of a bill to this effect being passed by the National Council (§ 79 (4) of the Rules of Procedure Act).

The Budget Committee is also responsible for participating in the budget management of the

Federal Government. Based on various statutory or constitutional provisions, the Federal Minister of Finance must submit reports in connection with the budget directly to the Budget Committee. These documents are referred to the Budget Committee (“Budgetausschuss”) directly upon receipt (so-called “BA documents” – “BA” being short for “Budgetausschuss” –, see Arts. 51 (7), 51b (2), 51c (3) and 51d (2) of the Federal Constitutional Law and § 32a (1) of the Rules of Procedure Act).

As is usual for specialised committees, other items of business relating to the budget may also be referred to the Budget Committee.

The Committee on Family and Youth also deals with matters relating to children's rights, the fight against child abuse, and childcare services.

7.2 Matters dealt with by the committee

The Finance Committee deals with all legislative proposals and motions relating to banks and public charges. This also includes the regulation of fees and taxes, exemptions and allowances. Pension funds and regulations for banks also fall within the remit of the Finance Committee. It should be noted, however, that the responsibility for oversight of the use of tax revenue lies with the Budget Committee and with the Court of Audit.

The responsibilities of the Main Committee are regulated in the Federal Constitution. These consist largely in participating in the federal executive function. For certain regulations enacted by the Federal Government to enter into force, they require the approval of the Main Committee (Art. 55 of the Federal Constitutional Law; § 29 (2) (g) of the Rules of Procedure Act).

The Main Committee makes proposals for the election of the President of the Court of Audit, the members of the Ombudsman Board, the chairpersons of the Parliamentary Commission for the Federal Armed Forces and the independent Control Commission for the Protection of the Constitution (§ 29 (2) (i) to (l) of the Rules of Procedure Act).

Furthermore, agreement must be reached with the Main Committee on the dispatch of soldiers and police officers abroad, for example to UN missions.

The Main Committee also performs an important function in its role as “EU Main Committee” by exercising rights of the Austrian Parliament to participate in the legislative process of the European Union. The Main Committee entrusts certain duties, such as exercising the right to issue opinions on EU projects, to its Standing Sub-Committee on European Union Affairs.

The Main Committee is traditionally chaired by the President, the Second or Third President of the National Council and their deputies. The leaders of the parliamentary groups are also usually members of the Main Committee.

The Main Committee elects its Standing Sub-Committee, which must be able to convene at any time. If the National Council is dissolved under Art. 29 (1) Federal Constitutional Law, it continues to exist in place of the Main Committee. In this case, the Sub-Committee shall assume the tasks of the Main Committee until a newly elected National Council convenes (Art. 55 (3) of the Federal Constitutional Law, § 6 (1) of the Rules of Procedure Act).

The Immunity Committee deals with requests from authorities, such as public prosecutor's offices or federal police directorates, for approval of the prosecution of a Member.

It deliberates on whether there is a connection between the alleged criminal offence and the political activities of the Member concerned and whether approval should be given for prosecution. The Immunity Committee may recommend that the National Council hold that no connection exists. This means that prosecution by the authorities is possible. If, on the other hand, the committee is of the opinion that there is a connection between the alleged criminal offence and the political activity of the Member (e.g. in the case of alleged participation in an unauthorised demonstration), the Immunity Committee generally recommends that public prosecution not be approved. The Immunity Committee also deals with notifications from authorities in cases where a Member is caught in the act of committing a felony (§§ 10 (2), (3) and (5) and 80 of the Rules of Procedure Act).

In addition, the Immunity Committee deliberates on requests by authorities for approval of the prosecution of the Federal President in accordance with Art. 63 (2) of the Federal Constitutional Law and on requests for the authority to prosecute persons for insulting the National Council (§ 80 of the Rules of Procedure Act).

The further information, reporting obligations and frequent legislative initiatives therefore relate to the last legislative term.

The Committee on Human Rights dealt with all legislative proposals and motions as well as reports relating to fundamental rights. This included human rights policy, racism and xenophobia, and anti-discrimination in Austria and other countries. It also covered, for example, the asylum procedure and the conditions of detention pending deportation. The European Convention on Human Rights (ECHR) and other international treaties were also recurring topics in the Committee on Human Rights.

The Ombudsman Board Committee dealt with the reports of the Ombudsman Board, in which the Ombudspersons reported annually on their activities. These reports (series-III annexes) cannot be finally dealt with in the Committee,⁹ but were considered in the plenary, where they were usually noted.

21.2 Matters dealt with by, and special functions of, the committee

The Court of Audit reviews the financial administration of the federal (and other) authorities and institutions on the basis of the adopted budget (supervision of the administration of public funds). The reports (series-III annexes) of the Court of Audit are dealt with in the Court of Audit Committee (cf. § 79 (2) of the Rules of Procedure Act). The Court of Audit submits to the National Council annual reports on its activities in the preceding year. In addition, it reports on audits of special acts of the administration of public funds (cf. § 99 of the Rules of Procedure Act). The Court of Audit may also carry out audits on its own initiative and report to the National Council about specific findings at any time (cf. § 79 of the Rules of Procedure Act, Art. 126d of the Federal Constitutional Law). The aforementioned reports are not dealt with in a final disposition procedure in the Court of Audit Committee.¹⁰ As a rule, reports of the Court of Audit are noted by the National Council.

The Court of Audit Committee also deliberates on all legislative proposals and motions relating to the Court of Audit and its powers.

The National Council may instruct the Standing Sub-Committee of the Court of Audit Committee to investigate a specific transaction in the area of federal administration. (The Sub-Committee is therefore informally termed as “small investigating committee”). Such an investigation must also be conducted at the request of one quarter of the members of the National Council (see Art. 52b of the Federal Constitutional Law and § 32e of the Rules of Procedure Act).

The Incompatibility Committee deliberates on notifications submitted to it by Members of the National Council, members of the Government and State Secretaries in accordance with the Incompatibility and Transparency Act. Members of the Government and State Secretaries must declare ownership of or shareholdings in enterprises, as the enterprise is excluded from public contracts above a certain equity stake. Members of the National Council must disclose leading positions in public limited companies, limited liability companies, foundations and savings banks. Members of the National Council working in the public service must report their exact area of activity, as an objective and unbiased performance of duties must be ensured (§§ 2, 4 and 6 (2) of the Incompatibility and Transparency Act).

On the basis of the notifications received, the Incompatibility Committee rules on the compatibility of positions held in the economy with the mandate. The notifications are dealt with in the form of final disposition by the committee. The decisions taken by the Incompatibility Committee and the measures taken by the President of the National Council on the basis of these decisions are notified to the National Council by the President (§ 13 (4) of the Rules of Procedure Act). If a decision of the committee is not complied with, the representative body or, in the case of the National Council, the Incompatibility Committee may file an application with the Constitutional Court for a ruling on the loss of office or seat (§ 10 (1) of the Incompatibility and Transparency Act).

The Committee on Research, Innovation and Digitalisation dealt with all legislative proposals and motions as well as reports relating to research, innovation, technology and digitalisation. This included regulations designed to make Austria an attractive business location for research and development, especially in the field of artificial intelligence. This included both the promotion and funding of research and the creation of general conditions for the efficient processing of funding applications. The Committee on Research, Innovation and Digitalisation also dealt with regulations providing for investment in telecommunications infrastructure or improvements in access to telecommunications services.

The Science Committee dealt with all legislative proposals and motions relating to higher education policy. This included universities and universities of applied sciences, human resources and students, teaching and research, access, quality and funding. The committee often deliberated on agreements concerning scientific cooperation. Animal testing also fell within the remit of the Science Committee.

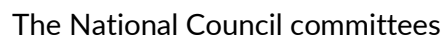

The Standing Joint Committee under § 9 of the Financial Constitution Act (i.e. the constitutional law governing financial relations between the federation and other territorial bodies) is composed of Members of the National Council and Members of the Federal Council. It serves to clarify certain disagreements between the federal and provincial levels of government: When the Federal Government has vetoed a bill adopted by a state parliament concerning public charges to be levied by the state or by the municipalities, the Committee decides whether the Government's veto remains valid or whether the state law can be promulgated. The Standing Joint Committee has its own Rules of Procedure.
